NOTES

1. There is an application fee of \$535.00 per application. You will be advised on how to pay the application fee normally within seven days after your application form has been received. There is **NO** need for you to make any payment in cash or in cheque at the time of application.
2. If your application is for change of the layout of the centre, three copies of the layout plans prepared by an Authorised Person **MUST** be attached to your application form. Please refer to the Guide to Positioning of Amusement Game Machines in your centre. If there is any change to the air-conditioning system in your centre, three copies of the revised air-conditioning plan with a certificate prepared by your contractor **MUST** also be attached.
- *3. If there is any change to the fixed electrical installation in your centre, a Work Completion Certificate (Form WR1) issued by a registered electrical worker and endorsed by you to be a true copy must be submitted to this office within one month from the date of our letter giving approval for amendment or variation of the conditions or particulars of a licence.
4. If your premises will be extended or reduced in size, a fresh Certificate of Fire Service Installations and Equipment (FS 251) issued by your contractor may be necessary.

6. The personal data provided by you in this application will be used for the following purposes :
 - (a) to facilitate assessment of the application for amendment or variation of the conditions or particulars of a licence;
